#### 253.1. Chairman's Comments.

Shiona welcomed everyone to the meeting.

She paid tribute to Angus Councillor Frank Ellis, who died on 7<sup>th</sup> April, after a long illness. Frank had been our councillor in the Sidlaw ward since reorganisation of local government in 1996 (and as a regional councillor before that). He was highly respected and worked tirelessly to represent our concerns to Council achieving many improvements.

# 253.2. Minutes of Meeting No 252

#### 253.3. Matters Arising

# a). Police Matters.

There was no report available

#### b). Car Park at the Road-end.

The lane running from near the wooden bus shelter towards the old railway line is private property on which parking is forbidden, - road signs to this effect have been erected.

## c). Traffic Matters

The Head of Roads has written to give the results of the revised speed survey on the B954 at Burnhead. Over a 7 day period in February the survey showed: average speed was 37.4 mph; 85% of traffic travelled at less than 45.7 mph (and 95% less than 49.4 mph); speeds were slightly less between 8 am and 9 am. He concludes that a speed restriction to 40 mph is not justified.

He has considered the resiting of the bus stop, which is used by 19 secondary children travelling to Monifieth HS, Websters HS, Dundee HS and other Dundee schools but considers the benefits do not justify the projected cost of  $\approx £32,000$ .

It was agreed that we should invite the Head of Roads to our June meeting. For this it is most important that there will be a very good turn out of the public especially from the Road-end area.

It was also noted that the Government have announced measures to allow Councils to introduce speed limits in rural areas more easily including a possible 50 mph limit on all rural B and C roads.

## d). Scheme for Establishing Community Councils

The model scheme has been issued from the Government working party and is available at website www.scotland.gov.uk/Topics/Government/local-government/CommunityCouncils. Angus Council has still to formally adopt this along with the model constitution, standing orders and code of conduct, but plan to do so in May.

# e). TACTRAN

No further development has been reported.

# f) STPR (Strategic Transport Project Review)

Angus Councillors were unanimous in backing Cllr John Whyte's motion to demand the removal of the bypass project from the STPR list of projects forthwith and to support the project of upgrading the roundabouts and associated junctions on the A90 Kingsway as the viable and preferred option.

# 253.4. Planning Applications

The appeal, against Angus Council's refusal to give consent to a new house at Old Balkello is in hand and a reporter visited the site today, 21<sup>st</sup> April. Unfortunately the appellant did not allow anyone from our council onto the site to attend the visit.

Applications for air source heat pumps at 5 and 7 Braeside have been submitted. There were no objections.

The owner of Lintrathen cottage explained his attempts to get permission to replace his house with a new house. The house can only be a 1½ storey building and must fit with the neighbouring houses. Angus planners have asked him to consider an innovative design which he believes would not be in keeping with adjacent houses. He wishes to build one in a traditional style. **Linda** agreed to contact the planner to clarify the matter.
