.1 Chairman's Comments.

In Shiona absence, Garry welcomed everyone and chaired the meeting.

.2 Minutes of Meeting No 261

.3 Matters Arising

a). Police Matters.

There was no report on current Police matters.

b). Traffic Matters

There was no further information on parking issues. Some development on "pudos" (pick-up and drop-off points) is expected from the Head of Roads, who has been in contact with John.

c). TACTRAN / STPR

John reported that improvements to the railway on the section Perth to Arbroath would start Dec 2011. This would include a new Invergowrie station and additional rolling stock. Tactran's next meeting will be on 15th June.

STPR Project 29 (upgrade of Kingsway or Dundee Northern Relief Road option) appears on the TAYplan Main Issues Report, - see d).

d) TAYplan

The Main Issues Report has been added to their website www.tayplan-sdpa.gov.uk. This sets out the main topics and challenges together with options for population growth and land development over the next 20 years. In addition other associated documents including an Environmental report for their area has been produced all for consultation over a 12 week period to 2 July. Public Information Events will be held: Enterprise House Greenmarket, Dundee on 4th May and 8th June; Library, Forfar on 17 May and Town Hall, Blairgowrie on 3rd June.

e) Angus Local Development Plan

The Development Plan Scheme (DPS) was produced last year and revised last month, - to be reviewed at least annually. Awareness raising and initial consultation is planned for this year with a formal Main Issues Report and consultation next year, - following one year behind the TAYplan consultation.

f) Recycling

A decision on further development of the recycling centre and improvement of the car park is awaited from Morag Grant.

.4 Planning Applications

a) The application for a storeroom extension to the hall has been withdrawn on Council advice. An alternative extension is being investigated.

b) There is no further information on the enforcement of planning conditions on Braeside development.
