292.1. Chairman's Comments

292.2. Minutes of Meeting No 291

The minute of the last meeting, which had been circulated, was approved.

292.3. Matters Arising

a). Police Matters.

Sean gave his report: -

Police Scotland would like to remind members of the public to remain vigilant against fraudulent activities, in particular advanced fee fraud. This is when a person is asked to provide payment in advance of promised wealth, gifts, prizes or employment. Contact can come by email, phone, fax or post. Fraudsters typically target individuals claiming to be from the Ministry of Justice, the government, Office of Fair Trading or a loan company. **Remember if it sounds too good to be true it probably is!** At our meeting on 21st Nov an Adult Protection& Review Officer will attend to talk about Financial Harm and to raise public awareness.

Acts of poaching and the theft farm equipment, diesel and manhole covers have been reported in rural Angus. Vandalism also remains an issue. Report anything suspicious to Police Scotland on 101. People driving in an antisocial manner and having noisy vehicles continue to be a problem. Report any suspect people on 101 or to Crimestoppers on 0800 555 111.

b). Road/Traffic Matters

The traffic problem at the entrance to Kirkton of Auchterhouse caused by cars parking on the road in front of the school was discussed at length. This and the replacement of the temporary bollards on the verge at West View will be taken up with the Roads Dept by the new residents of West View. The secretary will write to the Head of Roads to ask for clear communication with community councils before major work is undertaken in their area. The failure to do this before installing new lighting and resurfacing the pavements and roads in Kirkton of A. necessitated considerable discussion and changes to plans, as work was progressing. The final outcome, however, is excellent and greatly enhances the village.
