Everyone is reminded to remain vigilant against fraudulent activity and, in particular, advanced fee fraud. Be cautious using money transfer services. Only take advice from the Money Transfer Company and never share details of a money transfer with a 3<sup>rd</sup> party.

Thefts, and attempted thefts, continue to happen in the area. Residents are reminded of the importance of keeping their property and vehicles secure at all times

Sean has talked to all the school children on the topic of "Stranger Danger" and investigated reports of children being approached by strangers.

Drivers have been blocking drives when parking their cars in the village. This is a traffic offence which will be reported. Sean is investigating what further action can be taken to dissuade people from this irresponsible activity.

Some residents have reported children getting into/out off parked cars on the open road side (rather than the pavement side) on the main road in front of the school. Parents must ensure this highly risky practice ceases.
