306.1. Chairman's Comments

Shiona welcomed everyone to the meeting.

306.2. Minute of Meeting No 305

306.4. TOPICS

a). Police Matters.

There was no report.

Be vigilant and report anything suspicious to **Police Scotland** on **101** or **Crimestoppers** (anonymously) on **0800** 555 111.

b). Road/Traffic Matters

The result of the speed recording study on The Brae this month showed:

- Traffic going up The Brae averaged 34.9mph with 85% of vehicles travelling at less than 40.2mph.
- Traffic coming down The Brae averaged 33.1mph with 85% travelling at < 38.4mph.
- 202 vehicles went up the road per day on average, and 203 came down!
- 30 vehicles per day exceeded the speed limit (30mph) by more than 10mph going up the road and by 8mph coming down.
- 62mph, achieved by a maniac going up the road, was the maximum speed recorded.

The results will be discussed at the next Traffic Co-ordination Group meeting on 31st Mar and the Vehicle Activated Sign (VAS) will be reinstalled on The Brae for several weeks. It was agreed to ask the Group to consider direct Police action to "catch" speeding drivers and the Roads Dept. to carry out work to encourage drivers to stay below 30mph, e.g. rumble strips.

c). TACTRAN / STPR/NPF2.

Nothing to report.

d) TAYplan

The revised Proposed Strategic Development Plan for the 4 constituent councils (Angus, Dundee, NE Fife and Perth & Kinross) has been issued for consultation over the 8 weeks from 11th May to 3rd July. Information events, when planning staff will be available to discuss the proposed plan, will be held between 3.30 and 7 pm at the following venues and dates:

Forfar, Reid Hall on Tue 19th May and Dundee, Wellgate Central Library on Wed 3rd June

e). Angus Local Development Plan

The Proposed LDP has been issued showing the policies for the use of land in Angus and the sites proposed for development. It was noted that it is proposed to extend our cemetery up to the boundary wall with the school ground, as there may be no space left within 14 years. There was no objection to this. The proposed plan is open to consultation until midnight on 30th April.
