- 3. Minutes of AGM held on 23rd April 2013. Accepted as correct.

5. Report on Balkello Woodland

Outstanding work – which Robin will progress

- a) Control of the stream (running to the east from the car park) is nearly done just awaiting some final work at the overflow.
- b) Way markers have still to be positioned.
- c) The picnic tables are all installed, each complete with a hot plate. It was noted that one table had been bunt already plate not used.
- d) A notice board has to be made and installed.
- e) A notice about dog poo has to be made and displayed.
- f) The fence, at east end, requires repair.
- g) Dock to be sprayed shortly.
- h) Branches, overhanging the paths, need to be cut back. Bob will attend to this.

Some rowan trees have been planted around the car park. Bob has carried out the weaving of the new willow hedge.

Additional work to do

- a) Plan for the thinning of hardwood has been drawn up and submitted to District.
- b) Robin will contact Angus dog warden to get him/her to carry out a check on professional dog walkers (with up to 20 dogs) allowing dogs to run free upsetting other walkers and to confront owner of a vicious dog (alsatian x husky) which is still allowed to run free, although the owner has been warned by police.
- c) Barrier posts at entrance to overspill area are stuck and need attention.
- d) Post at gate out of car park needs to be reduced in height to avoid difficulty operating opening catch. Gorse will be planted at the side of this gate.

6. Report on Dronley Wood

Outstanding work

- a) The removal of fallen trees along north side, including beech, is main concern. Robin will determine when a contractor can be expected.
- b) A plan for the replanting of the clear fell area (north side) needs to be created.

Additional work to do

a) Robin will supply wire net to Iain Wilson for making fences alongside Dronley farm field more secure.

- b) Motor bikes have been taken into the wood although forbidden. Charlie Pirie from Atholl Security (tel: 07833354157) will investigate if contacted with details, e.g. registration numbers of bikes and/or van or trailer used to carry them.
- c) Robin will get 2 fallen trees, across path in south wood, removed.
